Dear Praying Friends,

Greetings in the name of our Saviour, the Lord Jesus Christ. Please pray for Susan's niece, Joanna Edwards. She is a precious 32-year-old saint of God who is currently in the fight of her life with a recently diagnosed, and very aggressive, cancer.

The meetings have been going well thus far this year. We've seen some folks make professions of faith in the Lord, as well as many say they have been convicted and encouraged to give Him more of the preeminence He deserves. I am asking whomever that feels led to do so, to write a short letter to each of the two addresses below on my behalf. If the ministry the Lord has entrusted Susan and I with has been a blessing or encouragement to you in any way, you might make mention of something to that effect.
